The Homestay provider fee is currently set at AUD\$270.00 per week. This amount is paid directly to Homestay providers via EFT by the School on a fortnightly basis, with a week in arrears and a week in advance. The School will also hold the bond of \$540.

Internet Access

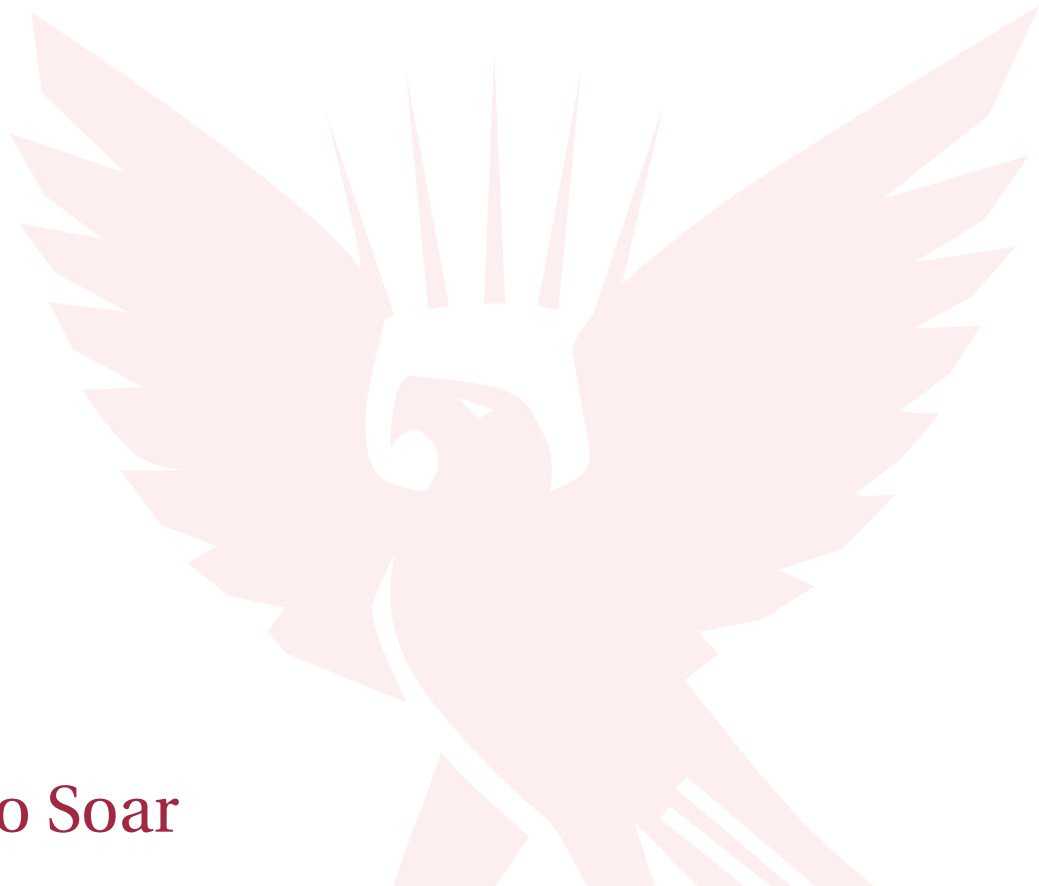
